**FACTS** What does PDQ Check Exchange llc dba Money 4 You/Mr Money do with your personal information?

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. <b>How does PDQ Check Exchange llc collect my personal information?</b>	We collect your personal information, for example, when you *Pre-qualify over the phone or fill out an application online *fill out an application in person
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only: * sharing for affiliates' everyday business purposes-information about your creditworthiness * affiliates from using your information to market to you * sharing for non affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

Definitions	
<b>Affiliates</b>	Financial or nonfinancial companies related by common ownership or control.
<b>Non affiliates</b>	Financial or nonfinancial companies that are not related by common ownership or control. * PDQ Check Exchange llc does not share your information with non affiliates.
<b>Joint marketing</b>	A formal agreement between non affiliated financial companies that together market financial products or services to you. * PDQ Check Exchange llc does not have joint marketing partners.
